Reconciliation is not something that can be forced- there must be shared goals and a clear path forward. I don't see this presently.

My recommendation is to please forgive one another from the heart, resist the temptation to be offended and accusatory, receive abundant grace from the Lord and keep no record of wrongdoing so that no root of bitterness gains a foothold in your lives.

I'm sorry for your distress and disappointment. There is grief in the loss of friendship. May the Lord bring peace and comfort to your hearts as you walk through this with Him.
